About Us:	<p>Evergreen Social Impact is a nonprofit fiscal sponsor organization that provides fiduciary services, funds management, governance, and other administrative services to projects with social-impact missions.</p> <p>Rather than each agency bearing the cost of the full array of staff, sponsored organizations can make use of only as much administrative support as the size of their organization needs. This shared infrastructure model maximizes efficiencies and provides tools, expertise, and a community of peer learning to organizations with limited resources.</p> <p>While Evergreen Social Impact provides the needed administrative resources, leaders in our sponsored projects are better able to focus on fulfilling their missions, building organizational capacity, and improving our communities.</p> <p>Our leadership team has more than 30 years' experience in nonprofit operations. Areas of expertise include finance, governance, human resources, grants and philanthropy. We have a unique competence in administering complex federal, state, and local grants, including compliance.</p>
Who We Serve:	<p>There are over 32,000 nonprofit organizations in Washington state, including public charities, private and public foundations and other nonprofits, including civic leagues, chambers of commerce and veterans' organizations.</p> <p>All told, they employ over a quarter million people, almost 10% of the state's workforce.</p>

Our nonprofits deliver vital community services, give voices to the people they serve, contribute to vibrant communities and advance solutions for the challenges we face.

One example is our featured sponsored project, the [Andy Hill Cancer Research Endowment \(CARE\) Fund](#), which makes cancer research grants in Washington state.

The CARE Fund is a bold public-private partnership, advancing transformational research in the prevention and treatment of cancer throughout our state. It leverages greater investments in our state through matching funds, and its investments result in health preserved, lives saved and extended, and families kept whole. And by partnering with Evergreen Social Impact, it keeps administrative costs to a minimum, and ensures compliance with state funding.
